Describe why you are selecting Comprehensive Distance Learning as the school's Instructional Model for the effective dates of this plan.

Horizon Christian Elementary and Middle School was prepared to provide On-Site Learning until the new Metrics for On-Site learning was released for Washington County and State of Oregon. The key ingredient for in person learning was Classroom size to determine the number of students per class with appropriate social distancing in the original plan. Horizon was capable of meeting the standards for 35 square feet per student for in person instruction. The County Metrics to re-open are not currently met and does not appear likely in the near future. Given the data to re-open school Horizon has committed to Comprehensive Distance Learning until we can safely return to in person learning. Staff have been trained on Google Classroom, communication has been shared with students and families on using google classroom. Student schedules are set and two daily schedules have been established to meet in-person instruction and distance learning.

Classes are all online and student will follow a regular schedule each day. All students can access support based on their personal academic needs.

When the county and state metrics are met for three weeks in a row, Horizon will return to in person on-site instruction. The classrooms are fully prepared for proper distancing between students, cleaning protocols are in place and standard operating procedures are set for students and staff entry into the building and transitioning between classes.
